Our World is changing

(1) Are there any other national or global issues or trends that we should take account of when preparing the Joint Strategic Plan?

If YES, please explain what these are and why they are important:

Nature loss - Nature is in decline across the whole country and without immediate action it is likely to decline further, including species and habitat loss. The JSP needs to address this directly and to identify solutions that embrace nature recovery. It is essential that conservation sites are protected, including European protected sites such as the Chilterns Beechwoods SAC. Where nature is likely to be impacted by development, there needs to be a strong and co-ordinated approach to delivering biodiversity net gain of at least 10%. We would like to see 20% in the Chilterns AONB. It is essential that wildlife sites are considered as interconnected networks and that new habitat linkages between sites are a priority. There is an opportunity of the JSP to make a real statement on nature recovery and to encourage a pro-active approach in all subsequent Local Plans and Neighbourhood Plans.

Net zero – The JSP needs to embrace net zero carbon and to clearly set out policies for making real improvements as part of its approach to addressing climate change.

Water management - Water usage, water quality and reducing the risk of flooding need to be fully addressed as a key priority in the JSP. The Hertfordshire part of the Chilterns contains a number of internationally important chalk streams. These are sensitive habitats that can be directly affected by the over-abstraction of water to serve new and existing developments. In an area where water resources are scarce, this must be a key consideration in planning new development. A strategic approach is also required to providing wastewater treatment facilities to avoid additional risks of sewage pollution to the water environment due to storm sewage overflows.

Sustainability - This must be an overarching theme for the whole plan. The environment must be put at the heart of the JSP and a long-term perspective is required as many species and habitats enhancements take a long time to establish.

Housing development – The JSP needs to include an approach to housing that fully respects the areas of Green Belt and AONB. These should be valid reasons for reducing the housing numbers required below nationally calculated figures.

HS2 – The JSP needs to recognise the impacts of the construction of HS2 and make a commitment to minimising and compensating for impacts on biodiversity and landscape.

Airport development – The proposed expansion of Luton Airport has the potential to impact on local communities and the tranquility of the countryside.

We agree with the list as far as it goes and are particularly pleased to see a reference to the importance of the Chilterns AONB and the chalk streams, commons and beechwoods it contains. The chalk areas of the Chilterns extend beyond the boundary of the AONB and also provide sensitive habitats and opportunities for nature recovery.

A strategic plan such as the JSP needs to be much more visionary and to seek real long-term change to society's attitude to the environment. Otherwise, our environment is likely to be in a much poorer condition by 2050.

The JSP should make links beyond the traditional remit of town planning and other environmental initiatives. In particular, there is a need to establish links between nature recovery through biodiversity net gain and enhancements to farmland through the Environmental Land Management Scheme (ELMS). In the Chilterns policies need to be aligned with policies for the water environment to enhance the Chilterns Chalk Streams.

Nature loss and recovery – This needs to be addressed at a variety of scales, from regional approaches working with neighbouring counties to more local community-led initiatives. One example of this is the Tring Wildbelt Project, which is being developed by the Chiltern Society in association with parish councils and other environmental organisations. The aim is to address nature recovery at a very local scale and to consider how networks of habitats can be created to aid the expansion of species. This model could be adapted for other parts of SW Herts.

Water environment - see above

Green Belt - The JSP should include a positive vision for the Green Belt. Whilst it is not strictly an environmental designation there is an opportunity to use the Green Belt more positively to aid nature recovery and provide Suitable Alternative Natural Greenspace (SANG) to provide for local recreation and take pressure off honeypot sites such as Ashridge.

Housing numbers – SW Herts is a highly constrained area with large areas of Green Belt and AONB. It is an area where there should be an opportunity to reduce housing numbers below the standard national calculations under the provisions of paragraph 11b and footnote 7 of the National Planning Policy Framework 2021. New development needs to prioritise brownfield sites, ideally within the existing built up areas to avoid encroachment into the countryside and the Green Belt.

Sustainable design – This should be promoted through the JSP and supported by design guidance. If we are to address water shortage issues and achieve net zero by 2050 then sustainable designs are essential for new houses and existing houses will require a comprehensive programme of insulation and retrofitting. The JSP provides an opportunity to co-ordinate these initiatives over a wider area and therefore to maximise potential gains.

Green Spaces – These are an essential part of living in SW Herts and can also make a significant contribution to tackling the nature emergency through new habitat creation and linking of existing habitats.

The main current and future infrastructure concerns for the Chiltern Society are the development of the HS2 railway line and the potential expansions to London Luton and Heathrow airports.

HS2 needs to be recognised in the JSP as it will have significant physical impacts on the JSP area, including the destruction of wildlife habitats and landscape change. Its operational phase will also increase noise impacts.

Airport expansion at Luton and Heathrow has the potential to create additional traffic in the JSP area to serve the airports as well as creating additional disturbance to residents due to overflying. Flightpaths will need to be carefully planned so as not to have a significant impact on the tranquillity of the Chilterns AONB and on the residents of local settlements.

The aim of the JSP should be to reduce road traffic through the Chilterns and not to create new roads to increase commuting to and from London.
